### **Information on the processing activity:**

#### **Purposes of the processing activity:**

The controller is a subsidiary of Wabtec Corporation, 30 Isabella Street Pittsburgh, PA 15212 - USA. Due to the standardized IT environment, processing also takes place in the United States of America.

We transfer personal data for the purpose of implementing projects within the Wabtec group of companies.

#### **Legal basis of the processing activity:**

The processing is necessary for the performance of a contract or a pre-contractual measure pursuant to Art. 6 para. 1 lit. b GDPR, the processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party pursuant to Art. 4 para. 19. in conjunction with. Art. 6 para. 1 lit. f GDPR and there are no overriding interests or fundamental rights and freedoms of the data subject.

In accordance with recital 48 of the GDPR, we have a legitimate interest in transferring personal data to affiliated companies of the Group for internal administrative purposes, including the processing of personal data of customers and employees.
